

## **Pigeon River Country Management Area**

## **Attributes**

The Pigeon River Country (PRC) Management Area, designated as a "special management unit" (now classified as a Forest Management Unit) by the DNR early in the 20<sup>th</sup> century, has approximately 105,000 acres of State Forest land. The PRC is centrally located between the communities of Gaylord, Indian River, Onaway and Atlanta.

- The State Forest land in the PRC MA is very concentrated, with only 7,450 acres of private land in-holdings.
- The State Forest land in the PRC MA was acquired over time through Game and Fish Fund purchases, tax reversion, private and government exchanges, and through various grants.
- A major oil and gas discovery in the PRC was made in 1970 resulting in associated industrial
  activity that caused concern about undesirable changes to the area. Oil and gas development
  was eventually restricted to the southern third of the Management Area. The oil and gas
  development led to the creation of the Kammer Land Trust Fund where royalties from Stateowned lands would be used to purchase new recreational lands for public use.
- The Pigeon River Country Forest Management Unit has an Advisory Council whose responsibilities include advising the DNR Director on plans, programs, activities and proposed management conducted within or affecting the Pigeon River Country.
- Pigeon River Country is the heart of Michigan's active elk population.

## **Concepts of Management**

A Concept of Management for the Pigeon River Country - November 2008 (originally adopted in 1973 and amended in 1983) provides policy and guidelines that are designed to protect the natural features of the area while providing for other compatible uses without harming important characteristics of the Pigeon River Country MA.
