




BRAVO MANAGED HUNT UNIT OF ALLEGAN STATE GAME AREA

BRAVO MANAGED HUNT UNIT (Crooked Lake Flooding) in ALLEGAN STATE GAME AREA SPECIAL USE AND HUNTING RULES

ALLEGAN STATE GAME AREA: The Michigan Department of Natural Resources created the Allegan State Game Area in 1964 by combining the Allegan State Forest, the Swan Creek Wildlife Experiment Station and the Fennville State Game Area. The 50,000 acre combined unit provides a wide variety of recreational opportunities throughout the year for everyone with an outdoor interest. It's found off I-196 via Glenn and Fennville exits, and off US-131 via Hopkins, Allegan, and Otsego exits.

The hunting seasons offer a wide variety of hunting opportunities during the appropriate seasons. Bird watchers enjoy the spring and fall migrations of waterfowl, warblers and many other birds. Thousands of Canada geese, mallards and wood ducks may be seen in March and April on the Farm Unit, three miles south of Fennville and in the Swan Creek Marsh, west of the Kalamazoo River along highway M-89. Cameras are welcome, but photographers must respect the refuge borders.

BRAVO UNIT: The Bravo Unit is an important night roosting area for migrant Canada geese. The focus of this unit is the Bravo Refuge Flooding. This flooding on the Utter Drain impounds over 80 acres of water nestled within a mixed oak and lowland hardwood forest to provide a sheltered roosting area. Thousands of Canada geese fly into this refuge each night in the fall. The following morning, they leave to feed (many to the Fennville Farm Unit) before returning to this water roost again in the evening.

BRAVO UNIT RULES:

1. It is unlawful to use or possess any shot, whether loose or loaded in shot shells, of a material other than federally approved non-toxic shot, except single projectile loads. BBB is the largest shot size permitted.
(See the Michigan Wildlife Conservation Order sections 3.411 and 3.414 for details).
2. Goose hunters must hunt within 25 feet of an established post. All posts are first-come first-serve, up to 3 hunters per post.
3. The Retrieving Zone is defined as the area between the posted Refuge Boundary and the 25 foot hunting limit from the established posts. You may enter Retrieving Zone only to retrieve "downed" game.
4. During the Allegan Local GMU season, no person shall have in their possession or fire from their shotgun more than 15 shot shells while waterfowl hunting in the Managed Unit.

THESE ACTIVITIES ARE PROHIBITED:

1. Shooting from parking areas, except as prescribed under a Use (Handicap) Permit, or from a safety zone.
2. Off-road vehicle (ORV) use is unlawful in Allegan State Game Area.
3. Leaving cans, glass bottles, or other litter (including spent shot shells), or to possess or consume alcoholic beverages.
4. Parking outside of designated parking areas. See map for parking lot locations, or call the Game Area Office.
5. Other Rules and Regulations for the State Game Area may be posted in the area;
look for additional signs or notices to insure you have a safe hunt.

CAUTION: Use care near all water areas; some of areas may contain deep water, depending on season and rainfall.

BE A SAFE HUNTER - A safe hunter obeys laws governing hunting and boating, is alert to any conditions hazardous to personal safety of the hunter and others.
