Drop the treatments on stands 87, 44, and 46. There is not commercial access to these stands and the Wildlife division has declined the opportunity to habitat cut these sites.

Stand 242 Change treatment type to other-species removal. Cut all deciduous trees greater than 2". Do not cut any conifer except jack pine. Do not cut any green painted trees. Mark a few wolfy oaks.

Stand 256 Cut all deciduous trees greater than 2". Do not cut any conifer except jack pine. Do not cut any green painted trees. Mark a few log sized deciduous trees.

Stand 275 Clear cut all jack pine and oak greater than 4". Do not cut any green painted trees. Mark a few wolfy oaks.

Stand 120 Clear cut all jack pine and oak greater than 4". Do not cut any green painted trees. Mark a few wolfy oaks.

Stand 48 Out of year of entry proposal for failed regen

Roller chop, trench and plant red pine with a next step of herbicide release if necessary.
