




Gratiot County



* A barrier-free accessible trail and hunting/photography blind are along the north side of Unit B.
* Although available for use by anyone, it's hoped consideration for use will be given to those individuals that have limited mobility, please.
* Other Rules and Regulations for the State Game Area may be posted in the area; look for additional signs or notices to ensure you have a safe hunt.

GPS coordinates at flagged point (white box):
[1] parking off east side Hwy 27, Taft Rd
Lat.43°08'47.6"N, Long.84°33'44.7"W.
[2] Accessible walkway to Accessible blind
Lat.43°08'48.9"N, Long.84°33'21.3"W.
[3] walk-over to reach observation tower
Lat.43°08'42.0"N, Long.84°33'03.7"W.



Important! 150 yards or 450 feet Safety Zones (No Shooting!) are enforced around all buildings and structures at all times. Always be careful around water and ditch/dikes for deep water!

Look for Watchable Wildlife viewing area signs in this area, for locations and more information about trails or features.

THESE ACTIVITIES ARE PROHIBITED

- a) Hunting or shooting from any dike, road, trail, safety zone, or retrieving zone (such as near refuge).
- b) Constructing a shooting pit or permanent blind. Portable blinds are permitted, but must be removed at the end of each hunt.
- c) Operate or use an amphibious or all – terrain vehicle or any other motor – driven vehicle in any area posted “wildlife refuge,” or any area posted against such use, except for vehicle authorized by the department.
- d) Parking outside of designated parking areas. See map for parking lot location, or contact the office for information.
- e) Enter any lands or water posted “Wildlife Refuge – Do Not Enter Sept. 1 – Dec. 1” without written permission of the management unit supervisor or their representative.
- f) Trap on any area posted “Wildlife Refuge – Do Not Enter Sept. 1 – Dec. 1” without a permit from the management unit supervisor or their representative.
- g) Use or possess an a shot, whether loose or loaded in shot shells, of a material other than shot approved non-toxic by the U.S. Fish & Wildlife Services pursuant to federal procedures.
- h) Other Rules and Regulations for the State Game Area may be posted in the area look for additional signs or notices to ensure you have a safe hunt.

CAUTION: Use care near all open water areas; some of these areas may contain deep water, depending on the season and recent rainfall.

BE A SAFE HUNTER - A safe hunter obeys laws governing hunting and boating, is alert to any conditions hazardous to personal safety of the hunter and others.
