### Compartment 10 – Stand Examiner James Park

Add Eastern Massasauga Rattlesnake specs to Stands 83, 102, 173, and 276. Consider making treatments to these stands a 3-year contract.

## Compartment 32 – Stand Examiner James Park

Merge Stand 2 from Compartment 32 with Stand 13 from Compartment 31 and apply same treatment over entire stand area with a target of 50% of the stand area harvested.

## Compartment 76 – Stand Examiner Matt Edison

Stands 11, 13, 26 and 82 – Remove unintended treatments to these well pad stands.

Stands 32, 47 and 77 – Wildlife to possibly add treatment to put in water level control features.

Add Eastern Massasauga Rattlesnake (EMR) treatment specs. to all treatments within the ERA designated area. Consider restricting periods for harvesting due to EMR area and possibly 3-year contracts for treatments.
