Authority: Part 5, Department of Natural Resources, Section 503(2), of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

Applicant: Kennecott Eagle Minerals Company, Marquette, Michigan.

Jurisdiction: Department of Natural Resources (DNR) State Surface and Mineral Ownership.

Surface Description: N ½ of NW ¼ and SW ¼ of NW ¼, Section 12, T50N, R29W, Michigamme Township, Marquette County, occupied premises to total 90 acres, more or less.

Lease Terms: Term of the Surface Use Lease is equal to the term of Metallic Mineral Lease M602. May be extended by Lessor as needed to extend through to conclusion of reclamation. Timber consideration fee based on 120 acres of forest land at \$1,722.00 per acre equals \$206,640.00. Monitoring fee of \$4,000.00 per year. Rental fee of \$241,300.00 to be split in two equal payments in the first two years. Subsequently, \$50,000.00 per year for years three through ten and \$50,000.00 as escalated by the consumer price index for years 11 and beyond.

Special Restrictions: Numerous restrictions regarding the use of the premises and restoration of the site are designed to enhance protection to the property.

Notice: This item appeared on the January 29, 2007 DNR Business Calendar and was noticed and available for comment and information at a series of public meetings September 10, 11, 12, 13, and 19. It was discussed and available for comment at the November 8, 2007 and December 6, 2007 NRC meetings. It is eligible for approval on January 10, 2008.
